

SOUTHWEST WASHINGTON FAIRGROUNDS

YEAR-ROUND EVENT AND FACILITY RENTALS

Southwest Washington Fairgrounds is a short term camping facility and campers are welcome to stay for 13 nights then need to exit the grounds for a minimum of 7 nights before returning.

Sites are based on fairgrounds event calendar availability. Check In: 2pm Out: 11 am

Reservations: Fairgrounds campsite reservations can be made in person upon arrival at the Southwest Washington Fairgrounds office or by telephone at the number listed below. Reservations are accepted on a first-come, first service basis. We require payment for your campsite be made at the time of the reservation (fees listed below) and is nonrefundable. A permit to camp on the fairgrounds will be issued to you after payment.

Camping Regulations

- Please park your vehicles completely within the correct numbered space. In order for us to properly patrol and protect our guests, it is important we are aware of who is located in each campsite.
- The vehicle parking pass needs to be kept in the vehicle window at all times. The vehicle can only be parked with the trailer; the parking pass **will not** be good in any of the regular fairgrounds parking lots. It is meant for **the car or truck** that is with your trailer
- To easily identify that the camper is properly parked, the RV camping pass needs to be put with your camper and in sight (possibly taped to the window) for the fairgrounds staff.
- Do not run electrical cords or water hoses beyond your immediate campsite (hoses not provided).
- Due to the fairgrounds' limited power capacity, we ask that you curtail the use of air conditioning to 20 amps per site.
- We have no dump station on site. We do not allow the dumping of any kind of waste onto the ground. There is a portable waste pumping service available for the guests and arrangements can be made by calling Goebel's Septic Service, (360) 736-2167. They require at least one day notice for service
- Please be considerate of your camping neighbors and keep noise to a minimum, especially in the early morning and late evening hours. Quiet hours are 10PM – 7AM (although be aware that events may have activities beyond that time).
- Fires are not permitted on the fairgrounds and only completely contained grills.
- NO SMOKING on property at all outside of your vehicle.
- Sites are limited to 4 people – additional campers are \$5 per person. Adding a tent is allowed within the size of your site at an additional cost of \$10 (which includes 2 additional people).
- Pets are allowed in the campgrounds and MUST be leashed, kenneled, or kept in your vehicle/RV at all times. Not all events allow pets to enter the fairgrounds/event itself.
- Alcohol is allowed in your RV/tent and no illegal/illicit activities allowed.
- WE RESERVE THE RIGHT TO REFUSE SERVICE TO ANYONE.
